Releasor understand the dangers associated with the Training Program, including, but not limited to, working in various types of PPE, lifting heavy loads, extreme hot/cold environments and working from heights, and affirms that he is not suffering from any impairment which might increase the risk of hard to himself and/or others. Releasor hereby assumes full responsibility for the risk of bodily injury, death or property damage, unless wholly caused by the negligence of Releasees, which participating in the Emergency Response Training Program.

Releasor expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Mississippi, and that if any portion there of is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Releasor acknowledges that photographs of training activities, as they are being conducted, and class photographs of trainees may be taken by the Releasees and hereby grants permission to Releasees to publish, reprint, reproduce and distribute any such photographs containing the image of Releasor for use in the marketing, promotional or advertising materials of the Releasees in the either hard copy of electronic form.
